IIMU extends Financial Aid to students in need of financial assistance. The objective of the Financial Aid Policy at IIMU is to ensure that no student is deprived of education at the institute for financial reasons. This process is intended for those students who have a pressing need for financial assistance.

All students whose annual household income is below 4,50,000 are eligible to apply. Other students with severe financial difficulties may also apply.

Students who are interested in applying for financial aid are required to fill the application form and submit it on **June 19, 2016**

Applications must include all the requested supporting documents, as applicable, or they will not be considered. Applications must be submitted on **June 19, 2016** at IIMU in a separate envelope superscribed "Application for Financial Aid".

Please note the following:

- (1) We encourage you to apply for the educational loan from Banks in parallel with this application since the funds available for financial assistance are limited.
- (2) Financial assistance is given only to those students who are assessed to have the need for it. The Financial Aid committee at the institute makes this decision based on the information provided by the applicant and a personal interview with him/her (if required).
- (3) Financial assistance is granted in form of tuition waivers depending on the assessment of the need for the same.
- (4) The committee reserves the right to verify the information provided by the applicant. If it is found that a student has knowingly given incomplete or false information, the student will face disciplinary action.
